

VACANCY ANNOUNCEMENT JUNIOR ENGINEER GRADE 12 ORANGE COUNTY DEPARTMENT OF PUBLIC WORKS

County Executive The Orange County Department of Public Works is now accepting applications to fill two (2) positions of Junior Engineer. These positions are allocated in the Competitive Class. The nature of these appointments are provisional pending the outcome of the Civil Service Examination Process. Civil Service Examination will be announced at a later date.

This is the beginning level of technical engineering work involving responsibility for the independent application of engineering principles in the construction and maintenance of highways and bridges. The incumbent works under the general supervision of a higher-level engineer allowing latitude for the exercise of independent judgment on assigned projects. Direct supervision may be exercised over subordinates to whom specific assignments are given and whose work is checked in progress and upon completion. Does related work as required.

MINIMUM QUALIFICATIONS: Either:

- (A) Bachelor's Degree* in Engineering, Geology or related field; OR
- (B) Associate's Degree* in Engineering Science or related field and two (2) years of experience in a sub-professional capacity in civil engineering; OR
- (C) Possession of Certification Level 2, related to civil engineering technology, from the National Institute for Certification in Engineering Technologies (NICET); OR
- (D) Graduation from high school or possession of a high school equivalency diploma and four (4) years of experience in a sub-professional capacity in civil engineering.

*NOTE:

Your degree or credits must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree or credits were awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency.
