Steven M. Neuhaus County Executive Applications are being accepted for the position of Director of Cybersecurity at the Department

of Information Technology Services. This position is allocated to the competitive class. The nature of the appointment is provisional pending outcome of a Civil Service Examination. Examination will be announced at a later date. The Director of Cybersecurity has a pivotal role responsible for establishing and maintaining a strategic cybersecurity program within county government. This position plays a critical role in safeguarding sensitive information, protecting critical infrastructure, and ensuring compliance with relevant regulations and standards. This is accomplished by creating, maintaining, and enforcing appropriate security policies and procedures; communicating and mitigating identified risks; developing and administering security educational strategies; and evaluating, recommending, and planning security driven initiatives.

MINIMUM QUALIFICATIONS: Either:

- A. Master's degree*, and two (2) years of experience in supporting cybersecurity, information security, computer science, network administration, system engineering, software development, or any legal or computer aspect that interacted with cybersecurity; and one (1) year in a project management or supervisory experience; OR
- B. Bachelor's degree* and three (3) years of experience as defined in (A) and at least two (2) years of project management or supervisory experience; OR
- C. Associate's Degree* and five (5) years of experience as defined in (A) above, two (2) years of project management or supervisory experience.

Note: Possession of a CISSP certification may be substituted for two (2) years of experience.

SPECIAL REQUIREMENTS: Posses and maintain a valid driver's license.

Note: Your degree or credits must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree or credits were awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. Note- Cybersecurity Information Security Officer (CISO) experience/qualifications preferred but not required.
