This position is allocated to the competitive class. The nature of the appointment is provisional pending outcome of a Civil Service Examination. Examination will be announced at a later date.

This is an important managerial and technical position responsible for the implementation and operation of computer systems and technical equipment. Technical work includes network administration, troubleshooting, telecommunication connectivity and support, database administration and management, computer-aided dispatch (CAD) support, and monitoring facility security systems. Along with operation, security and support of computer network and telecommunications equipment and software. The work is performed under general direction of the CIO and Commissioner and general supervision is exercised over technical personnel.

## MINIMUM QUALIFICATIONS: Either:

- (A) Bachelor's Degree (or higher) in Computer Science or related field and four (4) years experience as a network administrator; OR
- (B) Associate's Degree in Computer Science or related field and six (6) years of experience as defined in (A) above; OR
- (C) Graduation from high school or possession of a high school equivalency diploma and eight (8) years of experience as defined in (A) above.
- **NOTE:** Possess and maintain a valid driver's license.
- **NOTE**: Your degree or credits must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree or credits were awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency.
