MINIMUM QUALIFICATIONS: Either:

- (A) Completion of sixty (60) and one (1) year of work experience involving airport operations, maintenance or management; OR
- (B) Completion of thirty (30) credits and two (2) years of work experience involving airport operations, maintenance or management; OR
- (C) Graduation from high school or possession of a high school equivalency diploma and three (3) years of work experience involving airport operations, maintenance or management.

SPECIAL REQUIREMENT: Must possess and maintain a valid driver's license.
