Applications are now being accepted for the position of Clinical Instructor at the Valley View Center for Nursing Care & Rehabilitation. The nature of this appointment is temporary. Once the position is no longer encumbered, the appointment will become provisional, pending the outcome of a Civil Service Examination. Civil Service Examination will be announced at a later date. The work involves responsibility for developing, administering and conducting training programs for nursing assistants and allied nursing personnel in the Orange County Residential Health Care Facility. The work is carried out in accordance with established policies and procedures and involves coordinating the facility nursing assistant training program in compliance with the New York State health code and orienting certified nursing assistants to the facility. The work also involves designing and teaching programs to facility staff. Work is performed under the general supervision of the Associate Director of Nursing. Direct supervision is exercised over Nursing Assistants during their initial training period and nursing personnel assigned to assist with the training. Does related work as required.

MINIMUM QUALIFICATIONS: Either:

- (A) Bachelor's Degree in Nursing and two (2) years of experience in professional nursing activities in a nursing home, one (1) year of which was in a supervisory capacity; OR
- (B) Graduation from approved three (3) year school of professional nursing and three (3) years of experience in professional nursing activities, two (2) years which have been in a nursing home and one (1) year which was in a supervisory capacity; OR
- (C) Associate's Degree in Nursing and four (4) years of experience in professional nursing activities, two (2) years of which have been in a nursing home and one (1) year of which was in a supervisory capacity.

SPECIAL REQUIREMENTS: (1) Must possess and maintain current New York State Registered Professional Nurse registration. (2) Completion of a New York State Health Department approved trainer/evaluator program within six (6) months of appointment.

NOTES: Supervisory experience may be concurrent with experience in a nursing home or may be acquired in another professional nursing position.

NOTES: Your degree must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency.
