

VACANCY ANNOUNCEMENT

Public Health Engineer Trainee

DEPARTMENT OF HEALTH

Applications are now being accepted by the Department of Health to fill a Public Health Engineer Trainee vacancy. Civil Service Examination is a requirement for appointment to become permanent. Competitive Examination to be announced at a later date.

The trainee level is used to recruit into the public health engineering field, individuals who demonstrate a career interest in the public health engineering field with County government. Trainees receive on-the-job training while performing increasingly responsible and independent activities in the field of public health engineering as it applies to one or more of the specialized phases of the public health engineering program. Direct supervision may be received from Public Health Engineers or other technical superiors during the training period with final review of all projects by the Principal Public Health Engineer or Senior Public Health Engineer. Trainee appointments are for a period of one year, following which incumbents receiving satisfactory ratings will be advanced to the title of Public Health Engineer without further examination. Does related work as required.

MINIMUM QUALIFICATIONS: Either:

A. A Bachelor's Degree in engineering; OR

B. Possession of a license to practice as a professional engineer in New York State.

SPECIAL REQUIREMENT: Possess and maintain a valid driver's license.

Note: Your degree must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency.
