The Orange County Department of Public Works, Division of Environmental Facilities & Services is now accepting applications to fill the position of Engineering Aide. The nature of the appointment is temporary substitute. Once the permanent holder attains status in another position, this position will become provisional pending outcome of Civil Service exam. Civil Service Exam is required for permanent appointment (exam date to be announced at a later date).

This work involves progressively increasing levels of subprofessional engineering work including the completion of elementary engineering tasks and the use of engineering instruments on ordinary survey work. General instructions are given for routine tasks with specific and detailed instructions given for new duties. Does related work as required.

MINIMUM QUALIFICATIONS: Either:

- (A) Completion of thirty (30) credit hours with at least fifteen (15) credit hours in engineering, mathematics, science, surveying, architecture, or related field of study; OR
- (B) Graduation from high school, or possession of a high school equivalency diploma, and one (1) year of work experience in the field of engineering, land surveying, architecture, and/or construction; OR
- (C) An equivalent combination of the training and experience as indicated in (A) and (B) above.
- **NOTE:** Possess and maintain a valid driver's license.
- **NOTE:** Your degree or credits must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree or credits were awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency.
