ASSISTANT ENGINEER
GRADE 14
ORANGE COUNTY DEPARTMENT OF PUBLIC WORKS

The Orange County Department of Public Works is now accepting applications to fill two positions of Assistant Engineer. These positions are allocated in the Competitive Class. The nature of these appointments are provisional pending the outcome of the Civil Service Examination Process. Civil Service Examination will be announced at a later date.

The work involves technical and supervisory engineering duties including the exercise of engineering judgment on the design, investigation, control, maintenance, construction and operation of a county highway network. The incumbent works both in the field and in an office setting. Assignments are received from the Principal Engineer, allowing for independent judgment in planning work details and making technical decisions on routine matters. Supervision may be exercised over Junior Engineers and Engineering Aides. Does related work as required.

MINIMUM QUALIFICATIONS:

Either:

- A. Bachelor's Degree in Engineering and one (1) year of engineering experience; OR
- B. Associate's Degree in Engineering Science and three (3) years of engineering experience; OR
- C. Possession of Certification Level 3, related to civil engineering technology, from the National Institute for Certification in Engineering Technologies (NICET); OR
- D. Graduation from high school or possession of a high school equivalency diploma and five (5) years of engineering experience.

NOTE: Successful completion of thirty (30) graduate credit hours from a regionally accredited college or university or one accredited by the New York State Board of Regents to grant degrees majoring in civil or environmental engineering, or related field, may be substituted for one (1) year of engineering experience.

SPECIAL REQUIREMENT: Possess and maintain a valid driver's license.

Note: Your degree or credits must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree or credits were awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency.
