The Orange County Department of Public Works, Division of Environmental Facilities & Services, is now accepting applications to fill a Senior Sanitary Engineer position. This position is allocated in the Competitive Class. The nature of the appointment is provisional, pending the outcome of the Civil Service Examination Process. Civil Service Examination will be announced at a later date.

The work involves technical and supervisory engineering duties, including the design, construction, and inspection of environmental engineering projects. Work is performed under the general supervision of a Principal Sanitary Engineer or Deputy Commissioner with latitude for independent judgment. Supervision is exercised over assigned engineering and subordinate staff as may be required. Does related work as required.

**MINIMUM QUALIFICATIONS:** Either:

- (A) Bachelor's Degree in Engineering, Surveying, or related field and three (3) years of experience in engineering or construction; OR
- (B) Associate's Degree in Engineering Science, Surveying, Environmental Science, or related field and five (5) years experience as outlined in (A) above.

**SPECIAL NOTE:** Successful completion of thirty (30) graduate credit hours in a graduate college program majoring in civil or environmental engineering, or related field, may be substituted for one (1) year of required experience.

**SPECIAL REQUIREMENTS:** Possess and maintain a valid driver's license.

**Note:** Your degree or credits must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree or credits were awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency.
