Works with County department heads to define and analyze application system needs;

Conducts short and long term planning for needed application systems;

Assigns work, trains, and directs activities of staff;

Develops and monitors adherence to standards and procedures; revises as necessary;

Manages the daily performance and operation of supported applications; Prepares reports as required;

Attends training, demonstrations, and seminars to keep abreast of on-going technical changes and advancements of industry applications;

Collaborates with other departments to coordinate their application activities with those of the Information Technology Service Department.
