DISTINGUISHING FEATURES OF THE CLASS: This supervisory position is responsible for coordinating and managing all phases of administrative and labor related (automotive and heavy construction equipment repairs, replacement, rebuilding, etc.) activities of the County Garage. The work is carried out in accordance with established policies permitting considerable leeway for the exercise of independent judgment in planning and carrying out the details of the work. The work is performed under the general supervision of the Superintendent of Highway Construction. General supervision is exercised over the work of administrative support personnel in the County Garage, and the Automotive Shop Supervisor. Does related work as required.

TYPICAL WORK ACTIVITIES:

- 1. Manages and coordinates the operation of the County Garage and Central Motor Pool to maintain and ensure timely repair of County vehicles and heavy construction equipment;
- 2. Assigns operators to and schedules distribution of assorted equipment in order to maintain proper disbursement among various construction, maintenance, and snow and ice control projects;
- 3. Supervises and participates in preparation of requisitions, verifying orders and bills, control of stock inventory, budget control, and cost analysis of equipment operation and maintenance;
- 4. Prepares reports;
- 5. Schedules and oversees welding repairs and fabrication of bridge work;
- 6. Establishes priorities and coordinates personnel to accommodate workload;
- 7. Consults and transacts with vendors and repair shops;
- Oversees the computerized Fleettracker operation;
- 9. Participates in assessing and advising on needs for new equipment with the Superintendent of Highway Construction;
- 10. Maintains a safe work environment for personnel.

FULL PERFORMANCE KNOWLEDGES, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS:

Thorough knowledge of principles and practices of automotive or heavy construction equipment repair; good knowledge of modern office procedures and equipment; good knowledge of economical methods of requisitioning and purchasing automotive parts, tools, supplies and equipment; good knowledge of account keeping and stock control practices; working knowledge of current market conditions relating to highway construction and maintenance equipment and supplies; working knowledge of computerized operations; ability to compile and prepare reports; ability to coordinate and supervise the work of others; ability to obtain the cooperation of others; tact and courtesy; initiative and dependability; good judgment; physical condition commensurate with the demands of the position.

MINIMUM QUALIFICATIONS:

- (A) Completion of sixty credit* hours of study and four (4) years of experience in automotive or heavy construction equipment repair, two (2) years of which shall have involved supervisory responsibilities; OR
- (B) Graduation from a vocational technical or trade school with concentration in automotive or heavy construction equipment repair and five (5) years of experience as defined in (A) of which two (2) years shall have involved supervisory responsibilities: OR
- (C) Graduation from high school or possession of a high school equivalency diploma and six (6) years of experience as defined in (A), two (2) years of which shall have involved supervisory responsibilities; OR
- (D) An equivalent combination of training and experience as defined by the limits of (A), (B) and (C). No substitution or equivalency can be made for the supervisory experience.

SPECIAL REQUIREMENT: Must possess and maintain a valid Commercial Driver's License with a "B" classification (CDL-B).
