Maintains and repairs irrigation and well systems including operation of snow making equipment;

Inspects the operation of furnaces, boilers and air conditioning units and makes adjustments and minor repairs;

May inspect septic tanks and order plumbing supplies;

May perform general grounds keeping and building maintenance duties.
