Under close supervision, the employee learns and assists in carrying out various elements of prevention and control programs affecting the public's health by performing such work as inspection of food service establishments, water supply systems, camping sites, motels, hotels, bathing beaches, swimming pools, etc., to ensure compliance with the State Sanitary Code. Incumbents must be fluent in both English and conversational Spanish in order to provide services to Spanish speaking clients. Employment in this title is limited to one (1) Upon successful completion of the one-year training term the vear. emplovee is promoted to the title of Public Health Technician (Spanish/English Speaking). Does related work as required.

TYPICAL WORK ACTIVITIES:

Performs study and reading assignments;

Observes demonstrations and otherwise learns public health inspection techniques;

Learns and assists in making inspections related to public health programs;

Performs increasingly responsible duties as assigned.

MINIMUM QUALIFICATIONS: As prescribed in the Official Compilation of Codes, Rules, and Regulations of the State of New York (NYCRR) State Sanitary Code, Section 11.121:

- A. Associates Degree, including a minimum of 12 semester credit hours in the physical or biological sciences; OR
- B. Completion of 60 credit hours, including a minimum of 12 semester credit hours in the physical or biological sciences.

SPECIAL REQUIREMENTS:

- Must demonstrate the ability to speak, understand and write conversational Spanish;
- Must possess and maintain a valid driver's license;
- Satisfactorily complete a public health training course approved by the State Health Department within two (2) years of appointment.

NOTES:

- The term *natural science* shall mean a science such as biology, chemistry or physics that deals with the objects, phenomena, or laws of nature and the physical world. It shall include all physical and biological sciences. The term *applied science* shall mean science based courses in environmental technology, sanitation technology, medical technology, public health, infection control or food science.
