**DISTINGUISHING FEATURES OF THE CLASS:** This work involves responsibility for providing specialized and emergency Casework services to clients of the Mental Health Department. Incumbent performs intakes and assists with the evaluation of clients and providing casework services to patients with social, emotional and related difficulties associated with their mental condition. Work is performed under the general supervision of a higher level professional with leeway allowed for carrying out the details of the work. Supervision may be exercised over lower level professional and nonprofessional employees. Does related work as required.

## TYPICAL WORK ACTIVITIES:

- 1. Performs intakes and recommends admission of candidates for treatment or emergency services;
- Supervises and performs investigations for determination of client eligibility and services including collateral contacts;
- 3. Compiles case histories through contact with client, families, relatives, physicians and community agencies;
- 4. Prepares reports to the other members of the treatment team summarizing all pertinent information on the client;
- Assists in planning, implementing and reviewing individual client programs;
- Coordinates the activities of the treatment team within the clinic with services provided to minors by the various school systems in the County;
- 7. Performs casework services for clients, including home visits and participates in group treatment activity as a therapist.
