Coordinates Public Health Investigative Services with other health agencies for the delivery of patient care and treatment to prevent the spread of infection;

Supervises and assesses adequacy of services provided to patients and clients by public health investigators and auxiliary staff;

Investigates, surveys, and conducts follow-up of communicable disease/epidemiology issues, STD/HIV public health issues and assigns cases to program staff;

Assists in evaluating present and potential needs and resources for staff education and development;

Participates in surveys, studies and research in the field of public health;
